

## PROCEDURES FOR POSTPONED AND SUSPENDED GAMES:

1. IF A GAME IS POSTPONED BEFORE THE FIRST PITCH IS THROWN AND THE UMPIRES ARE AT THE GAME SITE. (I.E IF A 6PM GAME IS POSTPONED BECAUSE OF RAIN ETC. AT 5:55PM) EACH TEAM WILL PAY UMPIRES \$5 . IF THERE ARE 2 UMP THE VISITING COACH PAYS ONE UMP \$5 AND THE HOME COACH PAYS THE OTHER UMP \$5. IF THERE IS ONLY ONE UMPIRE SCHEDULED EACH COACH PAYS THAT UMPIRE \$3 (\$6 TOTAL)
2. IF A GAME IS POSTPONED EARLIER IN THE DAY AND UMPIRES ARE NOTIFIED IN ADVANCE THEN NO PAYMENT IS MADE. REMEMBER THE HOME TEAM COACH IS RESPONSIBLE FOR NOTIFYING VISITING TEAM AND UMPIRES. FAILURE TO NOTIFY UMPIRES WILL RESULT IN THE HOME TEAM BEING RESPONSIBLE FOR COMPENSATION OF UMPIRES. UMPIRES SHOULD ALSO TRY TO CALL COACHES AHEAD OF TIME TO VERIFY WHEN WEATHER CONDITIONS ARE QUESTIONABLE. THE AMOUNT OF COMPENSATION WILL BE DETERMINED BY COMMISSIONER AFTER WEIGHING CIRCUMSTANCES.
3. IF A GAME STARTS AND IS SUSPENDED OR STOPPED AT ANY POINT THE UMPIRES RECEIVE THE FULL FEE.
4. IF A SUSPENDED GAME IS RESUMED ON ANOTHER DAY, THE UMPIRES WILL BE COMPENSATED AS FOLLOWS.
  - A. IF THE GAME IS RESUMED IN THE 3<sup>RD</sup> INNING OR EARLIER THEN FULL PAYMENT IS TO BE MADE TO THE UMPIRES BY THE TEAMS.
  - B. IF THE GAME IS IN THE 4<sup>TH</sup> INNING OR LATER WHEN RESUMED THEN 50% OF FEES WILL BE PAID BY EACH TEAM
  - C. IF THE TEAMS AND UMPIRES MUTUALLY AGREE TO DIFFERENT FEES IT IS PERMISSABLE. (I.E IF ORIGINAL UMPIRES AGREE TO RETURN FOR LESSER AMOUNTS THAN THOSE LISTED)

**\*\* REMEMBER HOME TEAMS CALL YOUR UMPIRES 24-48 HOURS AHEAD OF EVERY GAME TO VERIFY THE GAME. LOCATION, DIRECTIONS, ETC .**
